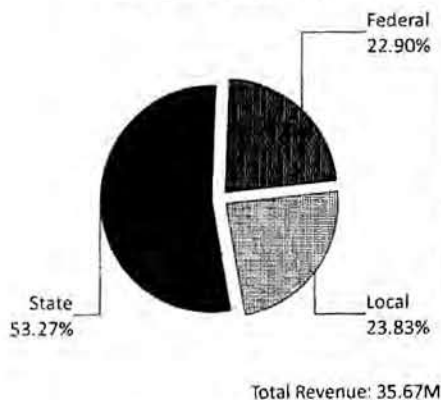

Revenue Sources



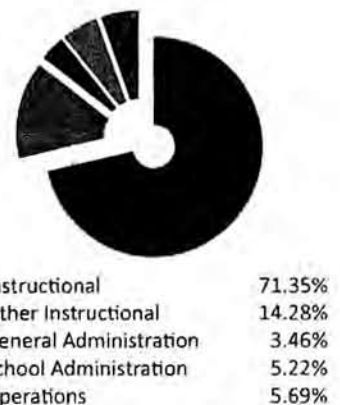
